
DESCRIPTION:

A TRACT OF LAND IN SECTION 23, TOWNSHIP 14 SOUTH, RANGE 3 WEST OF THE SIXTH PRINCIPAL MERIDIAN, SALINA, SALINE COUNTY, KANSAS MORE PARTICULARLY DESCRIBED AS FOLLOWS:
 BEGINNING AT A POINT ON THE NORTH LINE OF CLOUD STREET AND THE EAST RIGHT-OF-WAY LINE OF THE MISSOURI PACIFIC RAILROAD, SAID POINT BEING THE SOUTHWEST CORNER OF SAID TRACT; THENCE N 32° 28' 30" E ALONG SAID EAST RIGHT-OF-WAY LINE A DISTANCE OF 888.2 FEET TO A POINT OF CURVATURE OF SAID EAST RIGHT-OF-WAY CURVATURE BEING AT THE RATE OF 138' FOR A DISTANCE OF 888.2 FEET TO A POINT WHERE SAID EAST RIGHT-OF-WAY LINE INTERSECTS THE WEST RIGHT-OF-WAY LINE OF HIGHWAY U.S. 81 BYPASS SAID POINT BEING THE NORTHWEST CORNER OF SAID TRACT; THENCE S 40° 47' 30" E ALONG SAID WEST RIGHT-OF-WAY LINE A DISTANCE OF 888.1 FEET TO THE NORTHEAST CORNER OF SAID TRACT THE SAME BEING THE NORTHWEST CORNER OF THE U.S.A.R.T.C. GROUNDS; THENCE S 48° 18' 30" W ALONG THE NORTHWEST PROPERTY LINE OF SAID GROUNDS A DISTANCE OF 304.3 FEET; THENCE S 0° 15' 06" E ALONG THE WEST PROPERTY LINE OF SAID GROUNDS A DISTANCE OF 281.4 FEET TO A POINT ON THE NORTH LINE OF CLOUD STREET, THE SAME BEING THE SOUTHWEST CORNER OF SAID GROUNDS AND THE SOUTHEAST CORNER OF SAID TRACT; THENCE S 89° 44' 30" W ALONG THE NORTH LINE OF CLOUD STREET A DISTANCE OF 750.5 FEET TO THE POINT OF BEGINNING.
