

I HEREBY CERTIFY THAT THE BOUNDARY OF THE ABOVE PLATTED LAND WAS SURVEYED UNDER MY DIRECTION AND THAT ALL LINES AND POINTS SHOWN ARE TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE AND BELIEF, SAID LAND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: A TRACT OF LAND IN THE S.W. 1/4 OF THE NE. 1/4 OF SECTION EIGHTEEN (18) TOWNSHIP FOURTEEN (14), RANGE TWO (2) WEST OF THE SIXTH PRINCIPAL MERIDIAN, SALINE COUNTY, KANSAS DESCRIBED AS FOLLOWS: BEGINNING AT A POINT FOUR HUNDRED (400) FEET EAST OF THE N.W. CORNER OF S.W. 1/4 OF THE SAID NE. 1/4, THENCE EAST ALONG SAID 1/4 1/4 SECTION LINE SEVEN HUNDRED AND SEVENTY TWO AND SIXTEEN ONE HUNDREDTHS (772.16) FEET, THENCE SOUTH ON A LINE THAT IS PARALLEL WITH THE EAST LINE OF SAID 1/4 1/4 SECTION THREE HUNDRED AND SIXTY THREE (363) FEET, THENCE WEST ON A LINE THAT IS PARALLEL WITH THE NORTH LINE OF SAID 1/4 1/4 SECTION NINE HUNDRED AND FIFTY TWO AND SIXTEEN ONE HUNDREDTHS (952.16) FEET, THENCE IN A NORTHEASTERLY DIRECTION ON A STRAIGHT LINE TO A POINT THIRTY THREE (33) FEET SOUTH AND TEN (10) FEET WEST OF THE POINT OF BEGINNING, THENCE IN A NORTHEASTERLY DIRECTION ON A STRAIGHT LINE TO THE POINT OF BEGINNING, CONTAINING SEVEN AND SIXTEEN ONE HUNDREDTHS (7.16) ACRES MORE OR LESS.
