





WENDELL V., BERNARD W., & GERALD E. KNOWLES

DESCRIPTION OF TRACT

A tract of land lying in the Southwest Quarter (SW ¼) of Section Nineteen (19), Township Fourteen (14) South, Range Two (2) West of The Sixth Principal Meridian, Saline County, Kansas, being more particularly described as follows:

Starting at the Southwest Corner of said Section Nineteen (19); thence on an assumed bearing of North 0° 00' 00" East along the West line of said Section for Nine Hundred Ninety-four and Thirty-nine Hundredths (994.39) feet; thence North 90° 00' 00" East Fifty (50) feet to the Point of Beginning;

Thence North 0° 00' 00" East Three Hundred Thirty-one and Seventeen Hundredths (331.17) feet;

Thence North 89° 03' 04" East Four Hundred Seventy-one and Fifty Hundredths (471.50) feet;

Thence South 0° 00' 00" West Three Hundred Thirty-one and Ten Hundredths (331.10) feet;

Thence South 89° 02' 30" West Four Hundred Seventy-one and Fifty Hundredths (471.50) feet to The Point of Beginning, said tract containing 3.58 acres, more or less.
