

SPECIAL PICK-UPS

We offer a Special Pick-up service catering to specific items, including bags, tree limbs, large appliance (Freon removed), carpet, furniture, tires (additional fees apply) & boxes. To arrange this service, please contact us at (785) 309-5750. Prior to requesting the Special Pick-up, kindly place these items at the curb or in the alley for easy collection.

For Tree limbs, we ask that you cut them into manageable sizes that can be loaded by a single person. Any wood resulting from professional tree services should be managed by the respective contractor. It is the contractor's responsibility to dispose of materials and debris, including construction-related carpet waste.

The cost of this service starts at a minimum of \$27.00 per call, which covers up to 15 minutes of loading time. Any loading time beyond 15 minutes will be billed at a rate of \$27.00 per half-hour or fraction thereof.

If you're a non-City Sanitation residential customer, you're also eligible for our Special Pick-up service. The fee for this category begins at a minimum of \$54.00 per call, also including up to 15 minutes of loading time. Similar to the previous rate, any loading time surpassing 15 minutes will be subject to a charge of \$54.00 per half-hour or portion thereof.

OPERATING HOURS

Our sanitation workgroup operates Monday to Friday, with the exception of Thanksgiving, Christmas & New Year's Day. After these holidays, routes will be shifted by one day.

CART SETOUT

- Only items placed inside the carts will be collected. Items too large for the carts will require a Special Pick-up service.
- Position the carts within two (2) feet of the curb or alley, with the arrow pointing toward the street or alley.
- Ensure a minimum of three (3) feet of clearance from all sides of the carts to any obstructions (such as mailboxes, other carts, trees, vehicles, etc.).
- Carts obstructed by vehicles or other objects will not be emptied.
- Avoid placing carts near low-hanging branches or wires.
- Make sure the cart lids are fully closed.
- Avoid overfilling the carts, as excessive weight may prevent proper collection.
- Place carts at the curb or alley by 7:00 a.m. on the designated collection day.
- Retrieve the carts within 24 hours; do not leave them at the curb for an extended period.
- For containment, consider bagging refuse inside the carts, especially lightweight materials prone to scattering in the wind.

ADDITIONAL CARTS

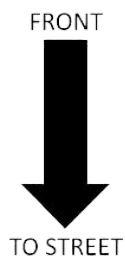
- Each additional cart costs \$3.00 per month.

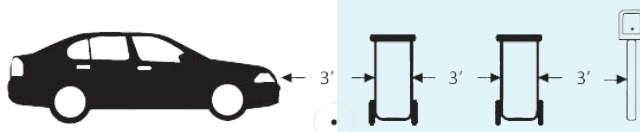

The SDRC functions as a "no-sort" facility, providing an avenue for all residents of Salina and Saline County, as well as small businesses, to recycle a diverse array of materials. The acceptable items encompass:

- Aluminum and steel (tin) beverage & food cans
- Cardboard & pasteboard (flatten for optimal space utilization)
- Glass containers in all colors, spanning food & beverage bottles & jars
- Reading materials such as magazines, catalogs, junk mail, office paper, newspapers & books
- Plastic containers for beverage, food & soap, encompassing plastics numbered 1 to 6
- Shredded paper - to be placed in separate bags (paper or clear plastic bags are preferred)

HOUSEHOLD HAZARDOUS WASTE (HHW):

We strongly advocate for the proper management of household hazardous waste (HHW) to divert it away from the Landfill.

- Household hazardous waste pertains to waste generated within residences that presents significant health hazards. These items might exhibit flammability, toxicity, reactivity or corrosiveness.
- Accepted items include household cleansers, pesticides, various paint products, antifreeze, engine and transmission fluids, fluorescent light bulbs & propane tanks weighing less than 2.5 lb., among similar products.
- Prior to delivering items to the facility, please ensure that lids are securely fastened and products are labeled, preferably with their original labels.
- Each participant is limited to disposing of five (5) gallons of liquid or a total of 50 lb. of waste during each visit.
- The facility only accepts residential household hazardous waste.

The Salina Municipal Solid Waste Landfill operates in compliance with the guidelines set forth by the Kansas Department of Health and Environment (KDHE).

- The disposal charges are determined by the material type and weight delivered to the landfill. For loads under 500 lb., the minimum fee is \$11.50 per vehicle. Secure loads weighing 500 lb. or more will incur a fee of \$46.00 per ton. Unsecure loads weighing 500 lb. or more will incur a fee of \$92.00 per ton. Additional charges are applicable for specific materials such as tires, dirt, rock, concrete, asbestos, contaminated soil and others. To obtain rates for unlisted materials, please contact us directly.
- Saline County residents can bring their secured yard waste, including brush, logs and stumps for free disposal. Unsecured yard waste will incur the minimum tipping fee of \$11.50.
- In accordance with state regulations, all loads entering the Landfill must be properly covered or secured to prevent litter from blowing or spilling during transportation.
- The Landfill is closed on Sundays, Thanksgiving, Christmas & New Year's Day.
- On Memorial Day, Independence Day, Labor Day, Christmas Eve & New Year's Eve, the Landfill closes early at 2:00 p.m.
